Goal: Recommended steps for civil society organizations on the effectiveness and future of sustainability initiatives as well as the development of concrete demands to be directed at corporate and political actors

For over 25 years global manufacturing has been accompanied by voluntary Corporate Social Responsibility measures. These are supposed to ensure that outsourced elements of the production process are carried out in accordance with sustainable corporate principle and not at the cost of people or the environment. Guiding Principles set out by the United Nations established a corporate duty of human rights due diligence (HRDD). But incidents like the Rana Plaza collapse, which killed more than 1,100 people, show that there is a gap between these principles and reality. The sewing facilities at Rana Plaza had been assessed several times by certification companies, including TÜV Rheinland. And this case is not a once-off: cocoa growing, cotton processing and the harvesting of tea and oranges all make clear that human rights violations and severe poverty persist in many industries which make use of certification.

This inaugural event will provide an overview of the limits and the potential of voluntary sustainability initiatives.
