Upcoming Events

29th EGOS Colloquium

From 4th to 6th July 2013, the 29th EGOS Colloquium with the general theme Bridging Continents, Cultures and Worldviews will be held in Montréal, Canada. The colloquium for the European Group for Organizational Studies (EGOS) will be taking place outside of Europe for the first time (www.egos2013.net). Georg Schreyögg, Freie Universität Berlin, Martha S. Feldman, University of California, and Jörg Sydow, Freie Universität Berlin, will convene the subtheme Bridging Time: Exploring the Dynamics of Routines and Path Dependence, which covers the temporalization of routines and the relations between patterns of persistence and patterns of change. A special focus will be on exploring the temporal patterning of and tensions between the logic of change in and through routines, and the self-reinforcing dynamics of stabilization in and between organizations. 28 papers have been selected from over 60 submissions for presentation at the Colloquium.

3rd International Conference on Path Dependence

The <u>3rd International Conference on Path Dependence</u> will be held in Berlin from 17th to 19th February 2014.

This will be an intensive, two-day conference with concluding panels and outstanding key-note speakers. A maximum of 50 participants will be selected to guarantee a workshop atmosphere. The sessions combine paper presentations and discussions including interactive elements. The conference will take place at the Seminaris Campus Hotel. Reasonably priced accommodation will be available; there will be no conference fee. Call for papers for a Special Issue of <u>Industry and Innovation</u> on "Field-Configuring Events as Arenas for Innovation and Learning", Volume 22, Issue 1 (2015).

The aim of this Special Issue is to analyze field-configuring events (FCEs) explicitly as arenas for innovation and learning from an interdisciplinary perspective. Since the coining of the term field-configuring events, the body of research on organized events such as trade fairs, conferences, or festivals has grown in different disciplinary contexts, particularly in management research, economic geography, and organizational sociology. This Special Issue aims to analyze the specific parameters that allow different kinds of FCEs to bring about novelty in different contexts and to specify the innovation and learning processes that take place in these dynamic arenas.

To be considered for publication, manuscripts of a maximum of 8,000 words must be sent electronically to the guest editor Elke Schüßler (elke.schuessler@fu-berlin.de) by October 1st, 2013. Please submit manuscripts as e-mail attachments. Following an eligibility check and quick quality check, papers selected for review will receive a double-blind review following Industry and Innovation's normal review process.
